We invite you to attend the [Cosmetic Bootcamp Summer Meeting](#) being held June 22-25, 2023 at the St. Regis Resort in Aspen, CO. This 3-day intensive meeting is a great way to continue your practical experience training in aesthetics.

We are pleased to offer the opportunity of the Grants shown below to help defray the cost of your attendance at the meeting. There are a limited number of grants available.

We are pleased to offer 2 types of Grants this year:*

- **\$500 Travel Subsidy Grants which include Complimentary Registration**
 - Subsidy to assist with travel costs plus complimentary registration (value \$250)
- **Registration Fee Grants**
 - Complimentary \$250 Registration Fee

*There are limited quantities of each grant, which will be awarded on a first-come first-served basis.

Award Criteria

- Applicant must be a registered Resident or Fellow at an accredited program in one of the core aesthetic fields of Dermatology, Plastic or Facial Plastic Surgery, Otolaryngology or Ophthalmology.
- A letter of recommendation from your Residency Program Director **must** accompany your application. Applications submitted without the letter of recommendation will not be considered complete.
- **Deadline for submitting applications with letter of agreement is May 2, 2023.** Applications received after this date will not be considered unless space is available.
- Applications are reviewed on first come/first served basis upon receipt of a completed application with a letter of recommendation.

Application Process

1. **Completed application form** (if handwritten, please print **legibly**) must be submitted by **May 2**.
 - Fellows must sign the Sunshine Act Acknowledgement.

2. **Letter of Recommendation from your Residency Program Director** must be submitted with your application and
 - a. state what year you are in, and that you are enrolled and in good standing in your program.
 - b. state that your Program Director recommends you to be a recipient of a grant.
 - c. be on letterhead stationery.
3. Send your completed application with letter of recommendation by **May 2, 2023** to Jane Fox: jfox@mdmeetingdesigns.com
4. You will receive notification by email regarding the status of your application. Once all spaces have been filled, a waitlist will be created.
5. If you are awarded a grant, you will receive an email notification of approval, with next steps including a **discount code to use for a complimentary registration**.
6. For those receiving the **Travel Grant**, once your attendance at the 2023 Cosmetic Bootcamp Summer Meeting has been verified, you will receive your grant check.
