

Collection and Processing of Data

To register for this course, you will be asked to submit your personal data, which will include your name, contact information (such as address, telephone number, email), professional credentials, and any other information requested on this site for the purposes of registering your attendance to specific events; assisting in the scheduling and payments of qualifying travel, lodging, and event expenses; and reporting any transfers of value as required by applicable law.

Purpose of Data Processing

A growing number of laws require greater transparency in the relationships between our industry and individuals and entities involved in providing health care. These laws impose various combinations of code of conduct restrictions on activities involving health care professionals and health care organizations and tracking and reporting of payments and transfers of value provided. Abbott policies require compliance with all such applicable laws, including the AdvaMed Code, Sunshine Act, and other region, country, and state specific laws and regulations.

Abbott will collect and process the information you enter on this site for the purposes of registering you for the course, providing any transfers of value (i.e., scheduling and payment of transportation, lodging, event expenses), and for the tracking and reporting of payments and transfers of value provided. This information may be publicly posted, as required by applicable law.

International Transfers of Data

Your data may be transferred out of your country of residence to other countries, including the United States, as required in the course of our business operations. These countries may have data protection laws which are different from your country of residence, and may have been deemed inadequate by the European Union and/or your country of residence. Abbott has taken steps to safeguard your information and will only make such transfers when required by applicable laws, based on a decision of your country or region's Data Protection Authority (i.e., European Commission) that permits this, subject to appropriate contractual provisions, or you provide your consent for such transfer.

Storage

Your data will be stored for as long as it is needed (i) to complete the course registration and record attendance; (ii) to schedule necessary travel, lodging, and other event related planning and Abbott covered expenses; (iii) for the tracking and reporting of payments and transfers of value provided.

Your rights as a Data Subject

Abbott ensures that specific rights required by some laws and regulations, including the General Data Protection Regulation ("GDPR") are provided to you in relation to your personal data. However, as your personal data is being processed for legal and regulatory purpose, some of these rights will be suspended

or restricted (including the rights to erase or restrict certain processing activities on your data). Your rights include:

- The right to rectify, or erase any wrong or incomplete personal data that Abbott holds about you;
- The right to access the personal data that Abbott holds about you;
- The right, in some cases, to object to the processing of your personal data on legitimate grounds;
- The right not to be subjected to automated decision making intended to evaluate certain personal aspects relating to you, such as analytics based on conduct. Please refer to the cookies section of the privacy notice for more information on how to exercise this right if it is indicated that cookies are being used;
- Where you have provided your personal data to us with your consent or as part of a contract, the right to the portability of that personal data to another person or, if it's technically feasible for us to do so, to another company;
- The right to lodge a complaint with your national data protection supervisory authority or to receive compensation for any damage you suffer; and
- The right to withdraw your consent to Abbott's processing of your personal data without detriment, where you have provided consent for Abbott to process your personal data.
