The maximum annual grant funding is limited to \$4,000, with the exception of Technology grants for a funding of \$5,000 every other year. All grant requests must be submitted on or before Nov. 30 for 2022 funds. General Purpose Grants and Education Grants will be accepted on or before December 30. Approved grant funds are available for 3 months, and funds will be distributed after submission of receipts/proof of purchase. Credit unions must fall within the ratios noted below. Credit unions outside of these ratios will be subject to further review by the grant committee, and additional documentation will be requested.

CREDIT UNION ASSET SIZE	NET WORTH RATIO	OPERATING EXPENSE / GROSS INCOME RATIO equal to or less than
Under \$10 Million in Assets	6.5 % to 21%	95%
\$11 to \$24 Million in Assets	6.5 % to 19%	95%
More than \$25 Million in Assets	6.5 % to 14%	90%

The Shapiro Group will disburse grant funds after final approval and proof of payment for services or purchase.
